
## The South Korean SAF Feedstock Market

- Special Act on Imported Food Safety (Managed by MFDS): Requires mandatory "Foreign Manufacturer Registration" for the supplier's facility *before* the first shipment can be imported. This is a critical first hurdle.
- Act on the Control of Transboundary Movements of Wastes (Managed by MOE): Demands rigorous proof and permitting to classify UCO as a non-hazardous feedstock for recycling, not a controlled "waste" product.
- Customs Act (Managed by Korea Customs Service): Involves complex documentation, classification, and clearance procedures that can cause significant delays and costs if not managed by an expert.
